I. 狗隻畜養人聲明

Statement from keeper of the dog

- 1. 本人自願在本表格提供個人資料,供漁農自然護理署(漁護署)簽發狗隻牌照及通知本人為狗隻續牌之用。 本人亦明白如本人沒有在狗隻牌照過期前為狗隻續牌,本人可能**會被檢控**。
 - All personal data herein are provided by me on voluntary basis for the purpose of issuing a dog licence and notifying me of renewal of dog licence by the Agriculture, Fisheries and Conservation Department (AFCD). If the dog licence is not renewed before expiry, I may be liable to prosecution.
- 2. 本人在此聲明,就本人所知及相信,有關資料<u>包括本人的地址及聯絡電話</u>等,正確無誤。本人明白若我作 出虛假聲明,本人可能**會被檢控**。
 - I declare that the information <u>including my address and contact phone number</u> etc. provided herein are, to the best of my knowledge and belief, true, complete and correct. I understand that I may be <u>liable to prosecution</u> if I willfully make a false declaration.

 - My address involves public housing estates under the Hong Kong Housing Authority or rental unit under the Hong Kong Housing Society, and I agree / do not agree* to transfer my personal data and data of all my registered dogs to Housing Department or Hong Kong Housing Society by AFCD for data matching according to my latest address declared to AFCD and understood that my above preference will not affect my application of dog licence.
