I. 狗隻畜養人聲明

Statement from keeper of the dog

1. 本人自願在本表格提供個人資料，供漁農自然護理署(漁護署)簽發狗隻牌照及通知本人為狗隻續牌之用。本人亦明白如本人沒有在狗隻牌照過期前為狗隻續牌，本人可能會被檢控。

All personal data herein are provided by me on voluntary basis for the purpose of issuing a dog licence and notifying me of renewal of dog licence by the Agriculture, Fisheries and Conservation Department (AFCD). If the dog licence is not renewed before expiry, I may be liable to prosecution.
