申請人注意事項 Notes to Applicant

1. 你必須年滿 18 歲。You must be 18 years old or above.
2. 你必須適當地完成申請表的所有部份。請以黑色或藍色原子筆以正楷填寫。You must duly complete ALL parts of this application form. Please complete this form in BLOCK letters using black or blue pen.
3. 牌照從簽發日期計，有效期一年。The licence is valid for ONE year from the date of issuance.
4. 你必須為登記雌性狗隻名冊中所列雌性狗隻的狗主，及其（根據第 421A 章發出的）漁護署狗隻牌照上列明的畜養人。You must be the owner and licensed keeper on the dog licence (issued under Cap.421A) for all the female dogs listed on the Inventory of Enrolled Female Dogs.
5. 不可安排年齡少於 18 個月及大於 74 個月的雌性狗隻生產小狗。Female dogs shall not give birth to puppies when they are under 18 months or over 74 months of age.
6. 參與繁育活動的雌性狗隻必須列入登記雌性狗隻名冊。請你亦留意在處所內可飼養的狗隻總數取決於處所面積及狗隻體積（見乙類繁育狗隻牌照營業守則）。Female dogs to be involved in breeding activity must be listed on the Inventory of Enrolled Female Dogs. Please also note the limit for the total number of dogs kept on the premises is based on the area of the premises and size of the dogs (ref. Code of Practice for Dog Breeder (Category B)).
7. 申請中的處所不可註冊為任何其他繁育狗隻牌照或動物售賣商牌照之領有牌照的處所。The premises under application must not be registered as the licensed premises of any other Dog Breeder Licence or Animal Trader Licence.
8. 你須附上一份有關申請處所的草圖。You must enclose a sketch of the premises under application.
9. 在牌照申請審批期間，你必須便利本署職員進入申請中的處所，使本署職員可實地視察整個處所。You must facilitate the access of AFCD officers to inspect the whole premises under application as required during the application process.
10. 署長在發出牌照時，可能考慮所有相關因素，包括申請者能否符合牌照條件及營業守則的規定。The Director may take into account all relevant factors, including whether the applicant can conform to the requirement in the Licence Condition and Code of Practice when issuing a licence.
11. 你應留意第 310 章《商業登記條例》之規定。Your attention is drawn to the provisions of the Business Registration Ordinance (Cap.310).
